San Mateo History Museum

Our tour on Sunday July 25 to Redwood City and the San Mateo County History Museum reminded me that we are fortunate to have so many things to see and do within a short drive from the City. The History Museum is one of them. The focus of the museum is San Mateo County history, much of which old timers like myself consider rather recent. The museum displays cover the development of post war suburban communities as well as development of the rail and highway systems from the mid eighteen hundreds through the 1940's and 1950's. The upper floor Sports Hall features high school athletes and their coaches, some of whom were contemporaries of mine. Coach Madden of Oakland Raiders fame and others that were household names also appear. The section on History Makers features inventors and entrepreneurs who began the technology revolution that led to the Silicon Valley we see today. The architectural features of the old courthouse by themselves are worth the price of admission.
